WHEN	: To be held on Saturday 21 st & Sunday 22 nd November 2015
WHERE	: Mingara Recreation Club, Mingara Drive, Tumbi Umbi NSW
STARTING TIME	: Games commence 9.45 a.m. <u>SHARP</u> both Saturday & Sunday
ENTRY FEE	: \$70.00 per nominated pair (players may pick own partners)
ENTRIES CLOSE	: Nominations (& entry fees) must be received by Thursday 19 th November 2015. 500pm.
PRIZEMONEY	: \$2000 * (subject to sponsorship and number of entries received)

*****Conditions of Entry*****

Competition Format

1. Tournament will be played on a handicap doubles basis, comprising of a round robin format on Saturday then a straight knock-out format on Sunday from 'Round of 16' onwards. (*subject to Entries).
2. Handicaps for all players will be allocated at the Tournament Committee's discretion and may be altered up to and including the 3rd round robin game.
3. Number of groups in round robin stage will be determined by total entries received, with each nominated pair required to play a minimum of 2 games within their round robin group. Morning and Afternoon sessions
4. All round robin games will be played over one or two frames. **Note** Black ball **MUST** be potted/fouled; or one shot each to end the frame. Aggregate needed for count backs.
5. Round robin performances will determine overall ranking positions for each nominated pair. Rankings will be based firstly on the number of games won, then best net aggregate score (i.e. for and against record).
6. If two (2) or more pairs remain tied (*with equal wins and identical for and against*) then the result of their respective round robin game(s) will determine final ranking positions.
7. Should these teams not have met in the round robin, then they will be split by way of a coin toss.
8. At conclusion of the round robin games the top sixteen (16) pairs will progress to Sunday's 'Round of 16' draw which will be seeded and conducted on a knock-out basis.
9. 'Round of 16' & Semi:- best of three (3) frames; Final best of five (5) frames.
10. **Dress code Saturday:** Tournament dress is optional. Neat & tidy casual dress standard will apply with a minimum of long trousers, collared shirt/blouse and enclosed shoes. No jeans, shorts, runners, thongs, etc. Disqualification will apply. **Dress Code Sunday: Tournament Dress** – Long sleeve plain shirt, dark coloured dress shoes, vest, long trousers. Tie or Bowtie.
11. **Tournament Committee reserves the right to vary the abovementioned format if considered necessary** subject to total number of entries received. **Tournament Committee decisions will be final.**

Nomination is by way of signed entry form which MUST be accompanied by entry fee.
 No entries will be accepted without entry fee and no entries will be refunded after closing date. Verbal entries may be accepted. All entries will be subject to acceptance by Tournament Committee.
